Plea of Nolo Contendere

I, the undersigned, do hereby enter my appearance on the complaint of the offense, to wit: charged in Municipal Court Cause Number _____. I understand that I have a right to a jury trial and that my signature on this **plea of nolo contendere** (meaning "no contest") will have the same force and effect as a plea of guilty on the judgment of the Court. I do hereby **plead nolo contendere** to said offense as charged, **waive** my right to a jury trial or hearing by the Court, and **agree to pay** the fine and costs the judge assesses. I understand that my plea may result in a conviction appearing on either a criminal record or a driver's license record.

Plea of Guilty

I, the undersigned, do hereby enter my appearance on the complaint of the offense, to wit: _____ charged in Municipal Court Cause Number _____. I understand that I have a right to a jury trial. I do hereby **plead guilty** to the offense as charged, **waive** my right to a jury trial or hearing by the Court, and **agree to pay** the fine and costs the judge assesses. I understand that my plea may result in a conviction appearing on either a criminal record or a driver's license record.

- I, the undersigned, request Deferred Disposition and understand that all court cost plus \$40 deferral fee is due immediately. Any moving offense during the 90-day deferral period will void the Deferral Disposition and this citation will NOT be dismissed. I also understand if under 25 years of age, the compliance of the Deferral requires taking the Driver's Safety Course. A provisional licensed holder (under 18 years of age) must be examined (take written test) by DPS under Sec. 521.161 (b)(2), T.C. and pay DPS a \$10 fee. I must submit the Court Copy from the Driver's Safety Class and proof of DPS test within 90 days of this plea.
